LAFARGE CEMENT GENERAL CONDITIONS OF SALE

Lafarge Cement is prepared, subject to the Conditions set out herein, to sell its products, in such minimum quantities as it may prescribe to the buyer on the Terms and Conditions recorded in these General Conditions of Sale. The General Conditions of Sale shall apply to all sales by Lafarge Cement of its products to the buyer.

1. The customer whose signature is appended on this form will make payments (no limit) into a Lafarge account at regular intervals chosen by the customer.
2. Subject to Clause 8, Account holder has the option to purchase Lafarge product(s) by redeeming part of or the whole amount deposited at any given time by making the relevant order for the product required.
3. Notwithstanding the date of collection and irrespective of whether an order may have been partly fulfilled, all products supplied will be at the Lafarge depot prices prevailing on the date of collection, unless the customer requests for an order for specified products to be raised on the date of deposit/payment. Product can also be collected from selected Lafarge retailers, at prices prevailing at the retailer on the date of collection.
4. All prices are inclusive of taxes and shall be paid in advance to Lafarge Cement Zimbabwe's bank account supplied. Prices do not include delivery cost.
5. No cash refund shall be paid by Lafarge Cement Zimbabwe. Customer will only redeem cash deposited through an equivalent amount of Lafarge Products.
6. No interest will be earned on cash deposited with Lafarge Cement Zimbabwe.
7. All prices are subject to alteration at any time without prior notice and Lafarge Cement Zimbabwe shall not be bound by any quotation issued to the Buyer whether in writing or otherwise.
8. Lafarge Cement Zimbabwe reserves the right in its absolute discretion to suspend supply of its products either wholly or partially as a result of:-
 - a) Fire, accidents, storm or unforeseen circumstances beyond the control of Lafarge Cement, Act of God, breakdown of machinery or vehicle, strikes, lockouts, Government Order, war or civil commotion.
 - b) Inability to obtain railway trucks or other vehicles, raw materials, fuel or packaging materials.
 - c) Or any circumstance beyond the direct control of Lafarge Cement.
